INDEMNIFICATION AND HOLD HARMLESS
AGREEMENT**

_____ (hereinafter referred to as Vendor) agrees to defend, indemnify, and hold harmless the Manteca Chamber of Commer, the City of Manteca, and all officers, board of directors, volunteers, sponsors, employees, contractors, and agents (herinafter referred to as "Listed Parties") from and against any and all claims, suits, liens, judgements, litigation, damages, losses, and expenses arising ou of vendo's actions in connection with the Manteca Chamber of Commer "Christmas in the Park" event.

Now therefore, in consideration of the mutual covenants and conditions contained herin, _____
_____ (Vendor) and the Manteca Chamber of Commerce agree as follows:

1. Hold Harmless: Vendor shall defend, indemnify, and hold harmless the "Listed Parties" from any and all actual or alleged claims, demands, causes of action, liability, loss, damage and/or injusry/ death (to property or persons, including without limitation), whether brought by an individual or other entity, or imposed by a court of law or by administrative action to any federal, state, or local government body or agency, arising out of or incident to any acts, omissions, negligence, or willful misconduct of Vendor. This indemnification applies to and includes, without limitation, the payment of all penalties, fines, judgements, awards, decrees, attorney fees, and related costs or expenses, and any reimbursements to "Listed Parties" for all legal expenses and cost incurred.
2. Authority to Enter into Agreement: Each pary warrants that the individuals who have signed this agreement have the legal power, right and authority to make this agreement and bind each respective party.
3. Modifications: No supplement, modification, or amendment of this agreement is allowed.
