Entry form must be submitted by November 24, 2023 at 5pm. Parade will begin at 5pm sharp, any units not in position will be placed at the end of the parade. Live Santas are not permitted on any floats. Floats and displays are cannot be more that 12 feet tall. All units must complete the entire route. Throwing of objects is strictly prohibited. Fire retardant materials must be used on all floats. Each float MUST have a fire extinguisher. No stopping at the judges stand. All entries must be family-friendly. Children under 12 must be accompanied by an adult. No loud noise or generators. Holiday lights are required for all entries.
