1. Hold Harmless: Vendor shall defend, indemnify, and hold harmless the "Listed Parties" from any and all actual or alleged claims, demands, causes of action, liability, loss, damage, and/or injury or death to persons or property, arising out of or related to any acts, omissions, negligence, or willful misconduct of Vendor. This indemnification includes, without limitation, the payment of all penalties, fines, judgments, awards, decrees, attorney fees, and related costs or expenses, and any reimbursements to "Listed Parties" for all legal expenses and costs incurred.

2. Authority to Enter into Agreement: Each party warrants that the individuals who have signed this agreement have the legal power, right, and authority to enter into this agreement and bind each respective party.

3. Modifications: No supplement, modification, or amendment of this agreement shall be valid unless made in writing and signed by both parties.
